Immigration - Through its ILS (Immigration Legal Services) program, Catholic Charities East Texas, a BIA (Board of Immigration Appeals) recognized agency, helps those immigrants in need regardless of their race, creed, or religion. We believe all are deserving of the basic human rights of food, shelter, education, protection, and health care. Our immigration legal department is staffed with BIA accredited personnel, who continue to receive regular monthly training with USCIS in Dallas and various educational conferences and webinars sponsored by CLINIC (Catholic Legal Immigration Network, Inc.) throughout the year. We provide immigration legal services as a way to reunite families and promote self-sufficiency for immigrants through low cost legal assistance in legal matters. Services include consultations and assistance with applications for Deferred Action for Childhood Arrivals (DACA), adjustment of status, naturalization & citizenship, and legal permanent residency, as well as VAWA (Violence Against Women Act), U- and T- Visa applications. In 2012, Catholic Charities assisted 403 clients.

Disaster Preparedness and Response - The Disaster Response program was established in 2005 in the wake of hurricanes Katrina and Rita, as evacuees poured into East Texas with little or no resources. Grants received from CCUSA (Catholic Charities USA), UMCOR (United Methodist Committee on Relief), and the Kenedy Foundation enabled Catholic Charities East Texas to provide two years of long term case management and financial aid to over 3000 in need of shelter, food, clothing, medicine, transportation, counseling, and relocation with moving expenses. An additional grant from CCUSA enabled Catholic Charities to provide assistance to three East Texas pantries, enabling them to restock shelves depleted during Hurricane Ike. Taking the lessons learned from these disasters, Catholic Charities developed a disaster readiness program including disaster preparedness manuals for individuals, families and churches, and training sessions for disaster readiness. The manuals teach preparedness, response and recovery for future disasters, from the smallest to the most devastating. Catholic Charities is also an active member of East Texas VOAD (Volunteer Organizations Active in Disasters), a coalition of non-profits with a mission of pooling resources to assist East Texas communities during disasters. In 2012, Catholic Charities maintained its disaster readiness program with its network of participating parish partners. In addition, through a TXU grant of \$35,973, the agency provided 289 families with 179 air conditioners and 110 fans. This emergency intervention gave families with small children and the elderly, all living below the poverty level, relief from excessively high temperatures during the Texas summer weather.

Roses For Food - The Roses For Food program began in 2007 to combat poverty through alleviating hunger in East Texas. Catholic Charities East Texas Roses for Food program provides technical and financial support to partner food pantries who are members in good standing with the East Texas, Houston and North Texas Food Banks. Funds are awarded annually and are based on availability and the number of applicants. Consideration is given to recommendations made by the food bank as to pantries most in need. Funds awarded are placed on account with the Food Banks for pantry use. Since 2007, we have funded over 1,000,000 meals. In 2012 we were able to provide \$2,500 to assist in the establishment of a new food pantry in Franklin, Texas.
