


Texas Muslim Women's Foundation supports women and their families by providing domestic violence prevention and intervention programs including a 24-hour Peaceful Oasis emergency shelter, transitional housing, financial empowerment, counseling, legal services, case management and domestic violence education to the general public. The Foundation also provides leadership and community service opportunities for youth and participates in interfaith collaborations to promote tolerance and understanding.

Client outreach & social services - Texas Muslim Women's Foundation provides client outreach & social services to women and their families from throughout the Dallas-Fort Worth metroplex who are victims of or at risk of becoming victims of domestic violence. During 2012, the Foundation provided comprehensive case management services to 329 individuals, legal services to 137 individuals, and counseling services to 48 individuals. The Foundation also maintains a 24-hour domestic violence telephone hotline as part of its outreach services.

4b (Code:) (Expenses \$ 91,198 including grants of \$ 84,414) (Revenue \$)

Financial empowerment & transitional housing - Texas Muslim Women's Foundation provides financial empowerment and transitional housing services to women and their children from throughout the Dallas-Fort Worth metroplex who are victims of domestic violence. Clients may reside in the Foundation's transitional housing for 6 to 12 months. During 2012, the Foundation provided transitional housing to 20 individuals staying in 3 apartments leased by the Foundation and provided rent-free to the clients. The Foundation aided another 245 individuals during 2012 by providing them with financial empowerment assistance such as rent, utilities, food, clothing and other basic needs.

Domestic violence emergency shelter - On December 26, 2012, Texas Muslim Women's Foundation opened its Peaceful Oasis emergency shelter to women and their children who need safe and confidential shelter from domestic violence. Within two days of its opening, the shelter had already provided refuge to 9 individuals. The shelter serves clients from throughout the Dallas-Fort Worth metroplex. Clients may stay at the shelter for up to 90 days.

Texas Muslim Women's Foundation (the Foundation) provides assistance to women and their families who are victims of domestic violence. The Foundation serves clients throughout the Dallas-Fort Worth metroplex. Oversight of the Foundation's assistance services is performed by its Executive Director, Board of Directors, Program Committee and Program Director who is a degreed and licensed social service provider with 15 years of experience working in the field of domestic violence and trafficking. The Foundation's Treasurer provides further oversight of disbursements for client assistance. The Foundation maintains written records of clients served and disbursements for client assistance. The Foundation has written policies prohibiting discrimination based on race, sex, age, disability, religion, political beliefs or national origin. Clients seeking aid are interviewed by Foundation employees who are either degreed social service providers or otherwise trained in providing such services. Initial approvals of client assistance are made by the Foundation's Social Services Committee based on the recommendations of the: 1) Case Manager who interviewed the client, 2) Program Director, and 3) Chair of the Social Services Committee. Recommendations of client assistance approved by the Social Services Committee are then submitted to the Foundation's President for approval. Upon the President's approval, documentation supporting disbursements for client assistance is submitted to the Foundation's Treasurer for approval. Upon the Treasurer's approval, client assistance disbursements are made directly to the landlord, utility company or other applicable third-party. Only in extremely rare cases are disbursements issued directly to a client and those disbursements are only for total amounts of \$200 or less.

Expenses for these educational activities totaled \$19,125 in 2012.
