THE FOUNDATION FOR RECOVERY CONTINUED TO EXPAND PROGRAMS AND SERVICES IN 2012 TO FURTHER ITS MISSION AND VISION. GENERAL PROGRAM EXPENSES WENT TOWARD THE FOLLOWING INITIATIVES. IN JUNE OF 2012, THE FOUNDATION FOR RECOVERY OPENED A PEER RECOVERY SUPPORT CENTER TO PROVIDE RECOVERY SUPPORT, ACCESS TO VITAL COMMUNITY RESOURCES AND AGENCIES, PARENTING AND LIFE SKILLS CLASSES, GED REVIEW, WELLNESS INFORMATION AND ACCESS TO COMPUTERS, PHONES AND EMPLOYMENT RESOURCES AND MORE. THE PEER COACHES ARE IN LONG-TERM RECOVERY AND PROVIDE A CRITICAL LINK TO THE RECOVERY COMMUNITY. THIS IS THE ONLY RECOVERY DROP-IN CENTER IN NEVADA. IN ADDITION TO THE PEER RECOVERY CENTER, THE FOUNDATION ALSO PROVIDES THE ROOMS, WHICH MAKES MEETING ROOMS AVAILABLE TO THE 12-STEP COMMUNITY, PROFESSIONAL DIVERSION, AND OTHER SUPPORT GROUPS. THE ROOMS IS THE HOST SITE OF MANY WORKSHOPS, SPEAKER ENGAGEMENTS, AND SPECIAL EVENTS. THE ROOMS ALSO HAS LECTURES AND PRESENTATIONS GEARED TOWARDS THE RECOVERY COMMUNITY, FAMILIES AND OTHER INTERESTED PARTIES. THIS CLASSROOM-STYLE MEETING SPACE IS AVAILABLE 24 HOURS A DAY, SEVEN DAYS A WEEK, FOR SUPPORT GROUPS. NOMINAL RENTAL IS CHARGED FOR THESE MEETINGS BASED ON THE NUMBER OF SELF-REPORTED PARTICIPANTS. GROUPS REPORTED THAT OVER 41,000 VISITS WERE MADE TO THE ROOMS FOR SUPPORT MEETINGS. SCHEDULES OF MEETINGS ARE REGULARLY POSTED ON THE FOUNDATION FOR RECOVERY AND ROOMS WEBSITES FOR EASY ACCESS. THE PEER RECOVERY SUPPORT CENTER ALSO HOUSES A COMPREHENSIVE INFORMATION CLEARINGHOUSE OF CURRENT INFORMATION ON PREVENTION, TREATMENT, RESEARCH AND RELATED ISSUES. FFR IS A DESIGNATED A NEVADA REGIONAL ALCOHOL AND DRUG AWARENESS RESOURCE SITE AND OFFERS A VARIETY OF EDUCATION AND OTHER INFORMATIONAL MATERIALS AND PUBLICATION FROM VARIOUS ENTITIES AND PARTNERS, INCLUDING THE SUBSTANCE ABUSE AND MENTAL HEALTH SERVICES ADMINISTRATION (SAMHSA), THE DEPARTMENT OF EDUCATION (DOE), THE PARTNERSHIP FOR A DRUG-FREE AMERICA, AND FACES AND VOICES OF RECOVERY. FFR'S PEER RECOVERY COACH TRAINING PROGRAM TRAINED AN ADDITIONAL TWENTY-FIVE PEER COACHES IN 2012 TO VOLUNTEER AT THE PEER RECOVERY SUPPORT CENTER. THE TRAINING IS A FOUR-DAY, 40-HOUR INTENSE TRAINING CLASS FOR MEMBERS OF THE RECOVERY COMMUNITY WHO WANT TO SERVE AS MENTORS AND GUIDES FOR OTHERS WHO ARE NEW IN RECOVERY OR CONTEMPLATING RECOVERY FROM DRUG OR ALCOHOL ADDICTION. INDIVIDUALS WHO ARE TRAINED ARE IN RECOVERY AND PROVIDE A VITAL LINK TO THE RECOVERY COMMUNITY. IN 2012 THE FFR INCREASED THE PRESENCE OF HYPER (HELPING YOUNG PEOPLE EXPERIENCE RECOVERY) AND WORKED WITH THE UNIVERSITY OF NEVADA LAS VEGAS TO INCORPORATE THE PROGRAM ON CAMPUS, AS WELL AS PARTNER WITH UNIVERSITY OF NEVADA RENO, TO BEGIN A COLLEGIATE RECOVERY ORGANIZATION, NEVADA RECOVERY AND PREVENTION (N-RAP), THAT IS STATEWIDE. HYPER AND N-RAP ARE A SUPPORT, EDUCATION AND OUTREACH SYSTEM BY AND FOR YOUNG PEOPLE. HYPER HAS ESTABLISHED A LOCAL CORE COMMITTEE OF YOUTH, AND HAS DEVELOPED NATIONAL CONNECTIONS IN THE YOUTH RECOVERY MOVEMENT. HYPER PROVIDES INFORMATION, PEER SUPPORT, AND HEALTHY CHOICE ACTIVITIES FOR ADOLESCENTS AND YOUNG ADULTS. THE PROGRAM IS IN THE PROCESS OF EXPANDING TO THREE CAMPUSES OF THE COLLEGE OF SOUTHERN NEVADA. THE FOUNDATION FOR RECOVERY CONTINUES TO PRODUCE AND DISTRIBUTE THE SOUTHERN NEVADA RECOVERY RESOURCE DIRECTORY TO THOUSANDS IN THE COMMUNITY. THIS PUBLICATION IS REGULARLY UPDATED AND PROVIDES THE LATEST INFORMATION ON LOCAL RESOURCES FOR SUBSTANCE ABUSE AND MENTAL HEALTH, INCLUDING RECOVERY RESOURCES IN THE COMMUNITY. IT CONTINUES TO BE A MUCH SOUGHT AFTER RESOURCE IN OUR COMMUNITY AND IS DISTRIBUTED AT NO COST TO NON-PROFITS, MEDICAL FACILITIES, LAW ENFORCEMENT, SOCIAL SERVICE AGENCIES, VETERAN GROUPS, COURTS, EDUCATORS AND COUNSELORS. FOUNDATION FOR RECOVERY HOLDS WORKSHOPS AND TRAININGS FOR ADDICTION PROFESSIONALS, RESEARCHERS, EDUCATORS, STUDENTS AND OTHERS TO DISSEMINATE THE LATEST INFORMATION ON SUBSTANCE ABUSE RESEARCH, TREATMENT AND RECOVERY. AN IMPORTANT ADDITION IN 2012 WAS THE FIRST COMMUNITY OFFERING OF A MENTAL HEALTH FIRST AID CLASS. MENTAL HEALTH FIRST AID IS AN EVIDENCE BASED PUBLIC EDUCATION PROGRAM THAT HELPS THE PUBLIC IDENTIFY, UNDERSTAND, AND RESPOND TO SIGNS OF MENTAL ILLNESSES AND SUBSTANCE USE DISORDERS. ANOTHER ADDITION WAS A PARTNERSHIP WITH UCLA TO BRING SCREENING, BRIEF INTERVENTION AND REFERRAL TO TREATMENT (SBIRT) TO THE PRIMARY CARE COMMUNITY. MORE THAN 125 HEALTHCARE PROFESSIONALS WERE TRAINED. IN PARTNERSHIP WITH THE NATIONAL MILLION HEARTS CAMPAIGN, FFR ALSO IMPLEMENTED AN INITIATIVE FOCUSED ON BRINGING WELLNESS INFORMATION TO THE RECOVERY COMMUNITY AND INCLUDED HEALTH FAIRS, CLASSES AND PERMANENT ADDITIONS OF INFORMATION TO THE PEER CENTER. THE PUBLIC OUTREACH EFFORTS THIS YEAR INCLUDED HOSTING A COMMUNITY PRESENTATION ABOUT THE AFFORDABLE CARE ACT WITH REGION IX ADMINISTRATORS FROM HHS AND SAMHSA. CLOSE TO A HUNDRED COMMUNITY LEADERS FROM PRIMARY HEALTHCARE, POLICY MAKERS, GOVERNMENT, BEHAVIORAL HEALTH, AND BUSINESS ATTENDED TO UNDERSTAND THE IMPLICATIONS OF THE ACA AND BEHAVIORAL HEALTH. OTHER EFFORTS INCLUDE A MORE ROBUST NEWSLETTER THAT GOES TO OVER 2,000 INDIVIDUALS AND AGENCIES. ALSO THERE WAS A STRONGER EMPHASIS ON SOCIAL MEDIA THAT WAS ABLE TO REACH A SIGNIFICANTLY LARGER NUMBER OF INDIVIDUALS AND GROUPS. OTHER OUTREACH INITIATIVES INCLUDED COMMUNITY EVENTS SUCH AS THE VETERAN'S STAND DOWN, WELLNESS FAIRS, AND COLLABORATIONS WITH COMMUNITY COALITIONS AND MULTIPLE NON-PROFIT, GOVERNMENT, LAW ENFORCEMENT, EDUCATION AND SOCIAL SERVICE AGENCIES, SOUTHERN NEVADA MENTAL HEALTH COALITION, SPECIALTY COURT JUDGES, SOUTHERN NEVADA HOLISTIC HEALTH COALITION, AND VETERANS GROUPS. THE 4TH ANNUAL RECOVERY RALLY WAS HELD IN SEPTEMBER TO COINCIDE WITH NATIONAL RECOVERY MONTH. IN 2012 THE FOUNDATION ADDED ADDITIONAL PARTNERS AND ORGANIZATIONS TO THE EVENT AND INCLUDED A PICNIC AND A MARCH THROUGH AN AREA NEAR THE COUNTY GOVERNMENT CENTER. OVER 1500 COMMUNITY MEMBERS PARTICIPATED IN THE EVENT, WHICH FEATURED RECOVERY SPEAKERS ALONG WITH LOCAL JUDICIAL AND LEGISLATIVE REPRESENTATIVES. THE FOUNDATION FOR RECOVERY ALSO HOUSES A LARGE SELECTION OF RECOVERY RELATED MEMORABILIA FOR VIEWING AND USE BY THE GENERAL PUBLIC WITH INTEREST IN THE HISTORY OF RECOVERY OR RECOVERY RESEARCH. THE ARCHIVE CONTAINS THOUSANDS OF INDIVIDUAL PIECES TRACING THE RICH HISTORY OF NATIONAL AND INTERNATIONAL RECOVERY MOVEMENTS, OFFERING A WEALTH OF ORIGINAL SOURCE INFORMATION TO RESEARCHERS AND STUDENTS.
