The mission of Come and See Africa (CASA) is to recruit, equip, and send Christian professionals and volunteers to eastern Africa for a structured missionary experience. These short-term missionaries lead Christian seminars, provide training in areas of their expertise, and minister to university students at the National University of Rwanda, meeting their spiritual and intellectual needs.

We work in association with Come and See Rwanda (CASR) to provide discipleship training in and around Butare, Rwanda

Come & See Africa International is assisting its sister organization called Come & See Rwanda to construct a Christian Mission House near the back gate of the National University of Rwanda. The address is #2 Mukoni in Huye, Rwanda. We are raising funds and sending cargo containers to help our Rwandan partners complete this project. This new building is called "The Lighthouse" and is an outreach to University students. The total estimated cost of the project is \$800,000. About \$600,000 has been raised through charitable donations. This new facility will support American missionaries while in Rwanda and facilitate our charitable cause. During the year 2012 major strides were made with the nearly \$200,000 wired to Rwanda. The third floor and rooftop were completed and an metal roof was installed. We are looking for a completion date of February 1, 2014

Come & See Africa International is assisting its sister organization called Come & See Rwanda as it ministers to students at the National University of Rwanda. We support them with a budget of \$2800 per month. This money pays for the rent of a house and for three salaries of locals. It covers food, hospitality, utilities, and a "compassion fund" that helps local widows and orphans. In 2012 we also helped with some graduation expenses at the NUR.

In 2012 Come & See Africa International sent two mission teams to Rwanda; one team of two, and one team of one. Each of these three persons was supported with \$1000. This covered transport and room and board. There was also several hundred dollars spent in Rwanda to support classroom training for university students.

CASR is registered as a non-profit organization by the country of Rwanda -- a difficult challenge. This CASR document is posted on line.

CASR is operated by its own independent board and is considered our sister organization. We are in daily email contact with CASR.

CASR sends to CASA two detailed monthly financial statements. One concerns monthly expenses to operate the current rented facility. The budget for this house is \$2800 per month. The second statement concerns the expense of construction. This statement details how construction money is spent. Either the director or the president of CASA visits the construction site twice a year to carry out an onsite evaluation of construction and to inspect financial record-keeping. This building has its own website at "lighthouse-huye.com". Pictures of construction progress are posted at the site.

CASA typically wires money from our Wells Fargo CASA account to CASR's Ecobank account in Kigali. We maintain records of all these wire transactions. We also maintain copies of all check donations and have printouts of bank statements back to 2006.

We also maintain thousands of photo and video documentations of our missionary activity and construction efforts.
