Scenicview Academy's employment unit continued to expand their services in 2012. Seventeen students were placed into off-campus employment settings. Twenty-seven internships were set up with sixteen different employers. Forty-five students participated in career counseling in 2012. Twenty-three students were assessed using the CASAS model. One student completed a four year apprenticeship program in Building Maintenance through working at Scenicview Academy, which is an approved facility to provide apprenticeships in Building Maintenance and Landscaping. Employment unit staff provided employability assessments, job development, job placement and job coaching services to clients of the Division of Rehabilitation Services, generating revenue of \$86,000. Employment staff and students assembled 72 kits for Why Try, Inc., generating revenue of \$10,800.

The mission of clinical services is to provide opportunities for individuals with learning disabilities to increase emotional, social, and cognitive skills that lead to a more successful interdependent life. Clinical services provides individual and group psychotherapy, psychological testing and recreational therapy services. In 2012, the clinical department participated with local universities in conducting research into effective approaches for teaching social skills. Clinical staff presented at numerous local, state, and national conferences. Clinical staff continued to develop curriculum, media, and exercises for the social skills class and lab. Recreation therapy staff provided ScenicView students with service opportunities for community organizations including non-profit groups, fundraising events, and assisted living and nursing home facilities. Recreation therapy classes introduced interest groups and small group activities as well as one-on-one activities.

In 2012, case management staff provided 10,115.5 hours of direct service to Scenicview students. Six of our seven case managers have a social service worker license and the seventh is completing her supervised hours and will be eligible for licensure in 2013. Scenicview funded a bachelor level intern position in 2012. It is likely that we will have interns going forward from this time. Students work in the case management department driving other students to appointments and on errands and staff to the airport. In 2012, eight student drivers provided rides for students and staff for a total of 2,414 hours.
