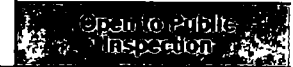

Over 2700 new low and middle income people were enrolled in CFR programs at Volunteer Income Tax Assistance sites, nonprofit housing-support, income-support, asset-building, and migrant worker community service organizations. CFR's financial education program integrates financial products into an experiential financial capability program motivating participants to work with financial coaches and practice beneficial financial behaviors such as direct depositing pay and benefits, automating bill payment, transferring funds to savings and prudent borrowing.
