d) We hold --one dozen local fund raising dinners, cocktail parties, and events throughout the Midwest each year

e) Most importantly, we have a program of partnering with leading prestigious universities to provide matching grants and other scholarships to our JIF scholars. These awards flow directly to our grant recipients and therefore do not show up on our books directly. We currently have relationships with Brown University, Harvard University, Stanford University, Johns Hopkins University, Emory, the University of Pennsylvania, among others. Over the past 5 years, these additional partners scholarships have totaled in excess of \$300,000 -- approximately 33% of the combined total funds received by our scholars. And this amount is growing (it was nearly 50% in 2012, and we expect it to remain in the 40-50% range for the foreseeable future).
