The all-male High School addresses every student's unique learning style and behavior. Instructors create individual educational plans for each student utilizing a unique collaboration of academic curriculum, social responsibility and relevant exposure to authentic life experiences. The school believes that structure and relationships are the cornerstone of academic success. The High School will have its first graduating class in the 2012-13 school year.

The Pro-Vision Middle School is a predominately male charter school governed by Chapter 12 of the Texas Education Code and functions as an external charter school with the Houston Independent School District. The Middle School targets students in grades 5-8 who are experiencing academic difficulty, behavioral challenges and other issues that have not allowed them to have success in a traditional school setting. The Middle School's educational paradigm emphasizes structure and classroom management in the educational process believing that students must first have a safe and structured environment before any learning can occur. The Middle School blends meaningful relationships with responsible adults, personal accountability and innovative educational techniques with traditional school curriculum.
