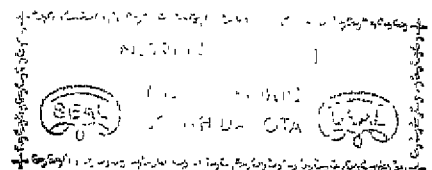

Jill Tennyson Memorial Scholarship

The Jill Tennyson Memorial Scholarship was established in 2006 by the Tennyson Family to honor Jill's love for learning and dedication to helping people. Jill was born December 13, 1978, and she lived and attended school in Custer, South Dakota. After her graduation from Custer High School she continued her education in college and earned her Master's Degree in Social Work in 2004. She returned to Custer to work in the community at the Star Academy as a drug and alcohol counselor and as a social worker at the Custer Regional Senior Care before she died on March 26, 2006.

The scholarship fund has been established to encourage and enable highly motivated Custer High School students to pursue educational opportunities which will prepare them to assist in solving society's problems. Each year one Custer High School graduate or graduating senior will be selected to receive a one time \$1,000 scholarship.
