CICAS conducts research in the development of surgical navigation equipment and techniques.

In 2012 CICAS worked independently to design the next generation surgical ablation systems by utilizing dynamic sources of imaging (i.e., Ultrasound Imaging) as means for interactive intra-operative guidance of minimally invasive surgical tools to the targeted pathology. The research involving Ultrasound navigation has yielded an early stage functional prototype illustrating the feasibility of dynamic and automated surgical guidance in soft moving tissue such as for the treatment of cancer lesions in the lung.

CICAS was presented in four international conferences in 2012 and had two peer-reviewed articles published during that period.
