Chances for Children operates a family style creche located in
Kenscoff, Haiti which provides a home to orphaned children. The creche
has capacity for up to 55 children and has a staff of 42 employees
providing a high caregiver to child ratio. An English-speaking
preschool teacher teaches the children and caretakers are encouraged to
engage the children in age-appropriate developmental play. The children
have access to a local pediatrician and a thorough medical screening is
performed on all children prior to admitting them to the creche. All
children are tested for HIV, VDRL, Sickie Cell, Hepatitis and TB, and
medical summaries are provided to adoptive parents. In addition to
operating the creche Chances for Children also provides assistance with
the adoption process for these children. Of the 55 children living in

Chances for Children provides monthly support to a few select
orphanages in Haiti. These orphanages provide long term care for 350
orphaned and abandoned children. Children at these sites live at the
orphanage until they are 17 years of age. Most have been abandoned and
adoption is not an option for them. The support Chances for Children
provides includes monthly donations of food, clothing, mattresses,
supplies, medicine and financial assistance. At 2 of the orphanages
Chances for Children helped improve conditions by funding construction
for renovations and repairs to add bathrooms and a kitchen. Chances for
Children staff makes bi-monthly visits to ensure child welfare and help
develop enrichment programs aimed at improving the children's lives. In
some sites, child sponsorships are available so that the children may
