Donations of \$500 or more to the Dixon Toys for Tots help support a food certificate or a senior citizen package for a family this year. The community support also helps underwrite another Toys for Tots season, of bikes, clothes, toys, food whereby Dixon residents demonstrating caring again as they have been doing for many years. During 2010, with the help of the above underwriters, more than four hundred families and over ninety seniors were served, on a needs basis, including food certificates and senior safety kits, in addition to bicycles, clothing, toys and warm coats for disadvantaged children.
