HISTORICALLY, KLM US HAS WORKED WITH A SOUTH AFRICAN FOUNDATION OF SIMILAR NAME, THE KGWALE LE MOLLO FOUNDATION, AN ENTITY FORMED UNDER THE COMPANIES ACT NO 61 OF 1973 OF THE REPUBLIC OF SOUTH AFRICA ("KLM FOUNDATION"). KLM US EXPECTS TO CONTINUE TO WORK WITH KLM FOUNDATION IN IDENTIFYING SCHOLARSHIP RECIPIENTS AND PROVIDING SUCH RECIPIENT TUITION AND MAINTENANCE SCHOLARSHIPS. HOWEVER, KLM IS SEEKING TO EXPAND ITS GRANTING AND SUPPORT ACTIVITIES TO ADDRESS A WIDER RANGE OF NEEDS IN UNDERSERVED RURAL COMMUNITIES IN SOUTH AFRICA. AS SUCH, IT IS LOOKING FOR, AND EXPECTING TO PARTNER WITH ORGANIZATIONS OPERATING WITH YOUTH IN THE AREA TO DEVELOP LEADERSHIP, MUSICAL, ATHLETIC OR ACADEMIC TALENT.
