Mangala Shri Bhuti, the grantee, is a contemplative community organized  
as a religious non-profit Colorado corporation under Article B of 501(c)(3),  
and is located in Crestone, Colorado. The funds were granted exclusively to  
apply to the construction of a Community Meditation Hall, Sangdro Palri Temple.  
This temple will provide a place where the community can gather for group  
meditation and regular ritual activities.  
The Grantee is required to clearly track the use of funds and to make  
semi-annual reportings on the progress of the project. The total cost  
of the construction of the Temple is projected to be \$1.5 million.  
This grant, therefore, provides only a part of the total project.

This grant to Tsoknyi Humanitarian Foundation, a Colorado nonprofit corporation,  
was made for the sole purpose of constructing a 3-Year Retreat Building  
at the Tsoknyi Gechak Ling Nunnery, a facility to house and educate approximately  
150 Buddhist nuns on Chobhar Hill near Kathmandu, Nepal. The building will be a  
secluded and secure ideal environment within the nunnery where prepared nuns  
will be able to meditate intensively for traditional 3-year periods.  
The Foundation expects to fund over time a total of about \$300,000  
to complete the construction of the retreat building.  
The Grantee is required to clearly track the use of funds and make  
semi-annual reportings on the progress of the project.

The Foundation offers a program, "The Book Initiative", which gives  
books, CDs, and DVDs of Buddhist teachings by our founder, Pema Chodron,  
to underserved populations. During the year it has given some 2,200 books  
and CDs to a variety of groups and individuals around the world.  
Some of the types of agencies that have been helped are cancer recovery  
groups, prison support groups, addiction recovery groups, AIDS clinics,  
homeless shelters, and abuse safe houses.  
It is felt that the Buddhist teachings can be especially  
helpful to people in great suffering or desperate circumstances.
