The Foundation is both a Type I and Type II supporting organization (SO.) The Determination letter we received from the Director, Exempt Organizations of the Internal Revenue Service classified us as a Type I supporting organization under section 503(c)(3). The Foundation is a Type I by design and a Type II by its actions. While the Foundation has been approved as a Type I organization, it also functions as a Type II.

A Type II supporting organization must be "supervised or controlled in connection with" the publicly supported organizations. The Foundation meets this requirement due to the fact that our PSO's have appointed personnel who have a close relationship and/or a supervisory position with the PSO because their appointees are people who are either on the PSO's board and/or are in management positions of their respective PSOs.

According to both our articles and bylaws, all of our board members shall be people who have been selected from the specific supported organizations that we support, and all our existing board members and all of the board members are from the supported organizations that are listed in our articles. Therefore we satisfied the requirements of Regulations 1.509(a)-4(g)(1)(i). Our board members are in supervisory positions with the PSO's they represent. Therefore, the board satisfies Regulation 1.500(a)-4(h)(1) in order to be considered a Type II SO.

According to both our articles and bylaws, all of our board members shall be people who have been appointed by the specific supported organizations that we support, and all of our board members are actively involved in our supported organizations. Therefore we satisfy the requirements of both Regulations 1.509(a)-4(g)(1)(i) and 1.509(a)-4(h)(1).

We have common supervision with our foundation and our PSO's: Francine Scinto is the President of the Board of Tustin Unified School District. She is also the President of this supporting organization. This is perhaps the single most obvious and clear example of common control. Dr. Walter Chwals serves on the board of PAPS and currently holds the position of secretary for that PSO. (He has also held various other educational positions with PAPS.) Anthony Marino has held past offices at Quinnipiac University.

In November 2013, the Foundation celebrated the following honorary professors: Professor Andri Smith, Professor Angela Mattie and Professor Leonard Engel who received the "Excellence in Teaching and Service to Students" award in 2013. The center for Excellence in Teaching and Service to students encourages, supports and recognizes superior teaching and service to students at Quinnipiac University. It helps the University achieve its educational mission, consistent with its core values: high quality academic programs, a student oriented environment and a sense of community. In lieu of this award and accomplishment, the Foundation put together a dinner at The View Restaurant in New York, in which the Professors' were applauded for there time and efforts put towards teaching.

Tustin Unified School District

After working closely with the Tustin Unified School District (TUSD), it was determined that it would most benefit by grants in the amount of \$3,000, which the district used for district office technology, educational supplies and equipment and educational programming to benefit TUSD. Specifically, the grant of \$2,000 (which was matched by the District) supported new technology in the boardroom.

Quinnipiac University

In 2013, the Foundation put forward many events in conjunction with Quinnipiac University. Firstly, the Foundation again sponsored a lecture on the subject of the use of poetry in everyday life at two Tustin Unified School District high schools by Quinnipiac University English Professor and renowned author, Dr. Leonard Engel. Plans are to repeat this visit in 2014 and to increase contributions to this event and to Quinnipiac's Engel/Scinto Colloquium, an annual educational event held at Quinnipiac University in

which QU students hold a public forum in which to present and discuss their original written works.

Secondly, the Foundation held a celebratory event at the View Restaurant in New York for the honorary teachers as mentioned in above paragraph in line 2.

#### Pacific Association of Pediatric Surgeons

As of November 30, 2013, a total of \$8,000 (including \$6,000 from previous years) has been granted to the Pacific Association of Pediatric Surgeons (PAPS). PAPS is an educational organization whose purpose is to train pediatric surgeons in new, life-saving surgical techniques. Scholar Benjamin Yapo, who was ill the previous year, attended the educational forum and symposia conducted by PAPS.

#### Grinnell College

An unrestricted grant of \$2,000 was granted to Grinnell College to provide to support their mission to educate its students "for the different professional and for the honorable discharge of the duties of life." The College pursues that mission by providing an education in the liberal arts through an open exchange of ideas.

#### Orange County Community Foundation

OCCF mission is to "collaborate with individuals, families and businesses to match their charitable interests with our community needs." A grant of \$52,000 to support address OCCF community's needs.

#### Amendment of Articles:

The Board of Directors amended the Foundation's Articles. Such amendment is in accordance with the regulation "...will be considered as meeting the requirements of this paragraph if the purposes set forth in its articles are similar to, but not broader than, the purposes set forth in the articles of its controlling section 509(a)(1) or (2) organizations." (reg. 1.509(a)-4(c)(2)). The following amendments were made:

"The Foundation is organized exclusively for charitable, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501 ( c ) (3) of the Internal Revenue Code of 1986 (or the corresponding provision of any subsequent federal tax laws). "

"The Foundation shall engage in, conduct, and promote religious, artistic, and environmental activities primarily in Orange County, California."
