Frontline Fellowship USA exists to glorify God by working for the fulfillment of the great commission We seek to serve suffering Christians, to speak up for the persecuted, exposing the persecutors, concentrating on neglected areas, evangelizing in restricted access areas, working for biblical reformation and praying for spiritual revival throughout Africa In doing so, we partner with our sister mission, Frontline Fellowship South Africa, to distribute literature, support and relief through various aspects of our ministry including our African book publisher, Christian Liberty Books

In 2012, Frontline Mission field teams completed multiple complex mission outreaches to Zimbabwe, Zambia, and Malawi This has involved pioneering ministry into neglected and remote regions Going literally off the map, the team crossed rivers by ferries and pontoons and visited and mapped 55 villages, many of whom said that this was the first time they had ever seen any white people The team conducted thorough creation Evangelism in 26 of these villages, laying solid foundations teaching on creation, the fall, the law and the need for a saviour We received invitations for us to come back and conduct leadership training courses and Evangelistic outreaches in far more parts of Africa than we have the resources to respond to Invitations for ministry to the Congo, Nigeria, Ghana, Liberia, Kenya, Malawi, Zambia, Zimbabwe, Uganda, and Sudan With the very limited means at our disposal we are attempting to do our very best to respond to these challenges and opportunities and to fulfill these needs in Africa We have major outreaches and leadership training programs planned throughout southern and central Africa early next year We are also wanting to acquire and drive up a suitable motorized boat for the Congo River Mission and establish a forward base on the Congo River The situation in many of these areas is desperate Aside from those who attended Frontline seminars and conferences, hundreds of postings were made under our library programme, to prison inmates and to pastors in Zambia, Nigeria, Zimbabwe, Tanzania, Uganda, Ethiopia, and Cameroon 25 participants received certificates for completing all the book reports from library program 1 and library program 2 We have received very positive feedback from pastors throughout Africa and continual requests for more books In 2010, we received, processed and distributed approximately 57 tons of bibles, books and gospel literature Much of this has been delivered and distributed across the borders into Zimbabwe, Zambia, and Malawi Mission stations, schools and churches throughout South Africa have also benefited from the containers of Great Christian Resources which have been donated to us
