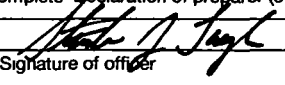

Expenses for the construction of the Stella Maris School & Lodge. Once complete, the income from the Lodge will serve as the primary funding source for the Stella Maris Primary School.

Construction accomplishments this year included completion of 2 classrooms and furnishing of 14 guest rooms. A business-grade electrical standby generator was acquired and integrated to the facility. An additional 9 guest rooms on the top floor were also improved to "rough finish". Common areas and kitchen facilities were also furnished as well as exterior landscaping. A van for the school and lodge was acquired.

Expenses for operating the Stella Maris English Medium Primary School. The school serves AIDS orphans and impoverished children of the village of Mailisita, Tanzania.

Operating expenses included teachers' salaries, food for the children, text books, water, and firewood.

The school served 120 1st, 2nd and 3rd grade children and an addition 80 Kindergarten and pre-Kindergarten children.
