Community Farm Connection sold over \$150,000 in local fruits, vegetables, meat, grains, and other farm products, while serving over 120 families, providing them with educational tools about eating seasonally and the benefits of supporting local farms. The Around Farmhouse Table program provided four educational workshops to approximately 40 participants. Community Harvest, CFC's newest program, put over 8,500 pounds of fresh produce into the existing regional emergency food system. The produce was gleaned from local farm sites by the hands of over 40 volunteers. Thanks to a grant from WSDA Specialty Crop Block, Community Farm Connection staff began plans for the Farm-to-Chef program, launched in the spring of 2013. Farm-to-Chef facilitates relationships between local small farms and wholesale
