The purpose of the clinic will be to provide low cost or free medical services and diagnostics for the local community. Plans call for the construction of this new clinic in 2013.

Our primary means of providing physical and connectional support to our target people groups is through sending small teams of volunteers to perform training, construction, project management, and medical care. Thus expenses in this category are related to travel, lodging, food, water, and materials provided to members of the target group.

4d (2) Expenses \$38,704

A special project completed in 2012 was the acquisition of commercial quality kitchen appliances and equipment which RHI provided to Souls Winning Ministries in La Plaine, Haiti for use in building a new orphanage kitchen.

4d (3) Expenses \$16,500

Part of the costs associated with supporting Haitian charitable and humanitarian work is that RHI is typically charged for containers of items or other donated equipment in order to clear customs. This expense represents the total expended by RHI in Haitian customs fees.

4d (4) Expenses \$16,237

In order to encourage sustainable food supplies and self-sufficiency among Haitians, RHI provided resources (in partnership with Irrigation Without Borders) in order to establish a viable farming operation, providing employment, family farming plots, and marketable agricultural commodities.

4d (5) Expenses \$12,595

Souls Winning in Ministries in Haiti was approached by a group of Haitian desiring to have a new church started in the southern coastal city of Jacmel. RHI provided funding support for temporary tent, sound system, computer, and transportation assistance for the new church's leadership.

4d (6) Expenses \$11,374

RHI assisted Souls Winning Ministries in Haiti with start-up funding for a new vocational technical school.

4d (7) Expenses \$9,091

Improvements were made to the furnishings and accommodations for the Haitian children in the Souls Winning Orphanage in La Plaine.

4d (8) Expenses \$5,500

RHI incurred specific duty/customs charges in Port-au-Prince, Haiti associated with the importation of a handicapped-equipped passenger van for use by Souls Winning Ministries.
