 One of the Central Oklahoma Humane Society's key components is our Adoption Program. The Central Oklahoma Humane Society (OK Humane) transfers animals into the Adoption Program primarily from the Oklahoma City Animal Welfare Division.

OK Humane utilizes the Meet Your Match<sup>SM</sup> SAFER<sup>SM</sup> (Safety Assessment for Evaluating Rehoming) behavior screening to make sure each animal is a good candidate for adoption. Animals are tested on their friendliness, playfulness, energy level, motivation and drive.

Without proper proof of vaccination records an animal admitted into the

 Over 17,000 dogs & cats are euthanized in Oklahoma City Animal Shelter every year simply because there are not enough homes. A compassionate society knows there is a better way to solve overpopulation than needlessly euthanizing unwanted animals.  
 The Central Oklahoma Humane Society (OK Humane) is proud to follow the highly successful clinic model based on Humane Alliance of Asheville, NC. With sponsorship from PetSmart Charities and the ASPCA, Humane Alliance developed the National Spay-Neuter Response Team (NSNRT) to mentor organizations in cities all over the country open high-volume clinics.

 The Central Oklahoma Humane Society's immediate goal is to end the needless euthanasia of healthy, adoptable pets in Oklahoma City. One initiative helping other communities around the country meet that same goal is a long-distance transport program. As hard as it is to believe there are actually communities that have a long list of adopters waiting for puppies and dogs! In order to be eligible to transport to cities that have receiving shelters, OK Humane must have the ability to quarantine the dogs to ensure their health before transport. The life-saving solution is our new quarantine facility that will enable populations of animals to avoid cross-contamination and provide the proper disease control to facilitate healthy adoptions and long-distance transportation.

We can operate on puppies and kittens as long as they are at least 8 weeks old and weigh 2 pounds.

Our clinic is open to anyone needing access to spay/neuter services with an income under \$40,000 per year.

Additional Services such as vaccines, testing, de-wormer and flea and tick treatment are offered only at the time of surgery. We do not offer "wellness" services for any non-surgical patients.

The Oklahoma City Animal Welfare Division (Oklahoma City Animal Shelter) admitted over 26,700 dogs and cats into the shelter in 2011. Approximately 18,500 of those animals were dogs and puppies. Of the dogs and puppies admitted, 30.5% of them were surrendered by their owners. Owner-surrender animals do not need to stay in the shelter for a stray time but frequently become exposed to life-threatening illnesses upon entering the general population at a traditional shelter. OK Humane constructed the Homeward Bound Transport Facility right next door to the Oklahoma City Animal Shelter so the OK Humane team can directly transfer owner-surrender dogs and puppies from the shelter into the quarantine facility. All dogs will be

health checked and vaccinated upon intake to protect against disease. After a two-week quarantine time groups of dogs will be transported in a specially outfitted transport vehicle to receiving shelters around the country. The Homeward Bound Facility is fully staffed to feed and care for the animals while they await the ride to their new homes.
