Also, discussions were entered into with Brandeis University for a new 5 year Post Doctoral position in ALS research. During this time BMF continued to raise funds to secure the means to support these 2 projects. In addition, the BMF continued its support of the ALS community via contributions to organizations whose mission is the advancement and betterment of those effected by ALS.
