New Mexico Showcase

New Mexico Showcase, a juried exhibition of New Mexico artists in celebration of 516 ARTS' fifth anniversary, welcomed guest juror Peter Frank, an acclaimed curator and art critic based in Los Angeles. Mr. Frank is currently Associate Editor of *Fabrik* magazine and art critic for *The Huffington Post*. The exhibition featured 80 emerging and established artists (of the 1,018 pieces submitted by 279 artists, Mr. Frank selected 73 artists and made seven special invitations to artists he wanted to honor). 516 ARTS opened five years before with an invitational exhibition of New Mexico artists. This time we used the juried format to cast a wider net and open up the opportunity to artists we might not have known about otherwise. Peter Frank selected a record number of artists ever to be shown at 516 ARTS in a single exhibition, highlighting the abundance of talent in New Mexico. The selected artists came from over 30 cities and towns across the state. Mr. Frank observed, "It was a delight, not a chore, to sift through the submissions, never knowing what was coming next, but reasonably sure it wouldn't be the same old same old. The hard part was winnowing the submissions down to a selection that could fit into 516's space, as capacious as it is, New Mexico's worthy art could fill it many times over." Artists' awards were announced at the opening reception. 516 ARTS published an exhibition catalog with an essay by Peter Frank, art critic and curator based in Los Angeles, CA.

- Feb 4 **Exhibition Opening event** at 516 ARTS, attended by the guest curator and nearly all of the artists, with live music featuring old-school country/rock-n-roll musicians The Joneses (Albuquerque, NM). Guest curator Peter Frank presented an introduction to the exhibition and announced several artists by his choice for artistic merit awards.
- Mar 17 **Panel Discussion: New Mexico Women Artists** featured participating women artists in the exhibition to discuss issues and opportunities facing contemporary women artists in New Mexico. This event was part of the *Women & Creativity* series coordinated by partners the National Hispanic Cultural Center and Creative Albuquerque. Moderated by Nancy Salem, artists were Rebekah Potter, Luanne Redeye, Valerie Roybal and Cedra Wood.
- Mar 24 **Poetry Reading and Book Release** for *Fixed & Free Anthology*, a collection of works by New Mexico poets by local poet/chef Billy Brown in conjunction with the exhibition.
- Apr 28 **516 WORDS: Judge for Yourself** poetry reading presented in partnership with the Local Poets Guild in celebration of National Poetry Month. The reading featured New Mexico poets from the fields of Law, Politics, Environmental Advocacy and Education, including Erin Northern, Raymond Zachary Ortiz, Bill O'Neill, and Beata Tsosie-Peña.

Wendover Landing

As part of the *Time Pieces* series of collaborative projects exploring time and place, poet Miriam Sagan launched *Wendover Landing*, an interdisciplinary art piece merging poetry and sculpture, which asked the questions: What is our position vis a vis our own personal histories? How do we understand and express the history of the time into which we were born? How do we locate ourselves – as artists and as people – in relationship to these narratives? Sagan's poetry was combined with a textile installation by Alisa Dworsky and a flock of porcelain messenger pigeons by Christy Hengst in the front of the gallery. Sagan said, "Our notion of the world may be continually expanding, and yet human habitation and a sense of home give the observer a position from which to create. Where is home located in relationship to time, starting with the deep geologic, and continuing to the ephemeral present moment?" and explains, "Wendover, Utah is the site of the Enola Gay hangar and was an airforce base during WW2, now abandoned – a launch from it implies the atom bomb and the destruction of Hiroshima. The 'landing' is about many things: cause and effect come home to roost, the poet in a dystopic landscape, and the more redemptive image of Christy Hengst's dove-like birds and Alisa Dworsky's winged tent structures settling down peacefully. With both ascent and descent over a barren landscape there is hope in some healing from the imagination. The catalog included an essay on *Wendover Landing* by Miriam Sagan and excerpts from her poems.

Common Language

Common Language, Punctuating the Landscape by two west Texas artists, Suzi Davidoff and Rachelle Thiewes, consisted of lush, large-scale photographs printed directly on aluminum and a twin-screen video production. Their project began with a joint residency at Fiskars Village, an artist's cooperative in Finland. They created several site-specific installations that responded to the natural landscape.

and architectural/historic structures by incorporating foreign objects and materials. Returning to the Chihuahuan desert, they continued the project as a conversation with the forested Finnish landscape. Each installation could be experienced in person for a short time before it was dismantled or worn away by natural forces. Because of the temporary nature of the installations, the process of photography became an extension and record of the sites and a central component of the artists' finished project. One image has been selected from each of the 20 installation sites and printed large scale directly on aluminum. Two videos will be projected on walls and floor in conjunction with the photographic installation. The exhibition was accompanied by a hardcover book with photographs and text relating to the project and process, with a special artist proof edition. The 516 ARTS catalog included an essay by Mary Anne Redding, Chair, Photography Department at Santa Fe University of Art & Design.

Friends of the Orphan Signs

Friends of the Orphan Signs, an exhibition in the upstairs gallery organized by artist/curator Ellen Babcock, showcased historic Albuquerque road signs alongside artwork created in response to them, focusing on a dialogue between historic content and contemporary art practices. Friends of the Orphan Signs is a collaborative, public art initiative directed by Babcock, which utilizes abandoned road signs as sites for community generated public art. Once glowing with the neon life-blood of the Mother Road, road signs along Central Avenue have become skeletal remnants of their former selves. In a series of interventions both actual and proposed, Friends of the Orphan Signs, in collaboration with the city of Albuquerque Public Art Program, infused these sites with the creative voices of our community. Featured projects in the exhibition presented histories of signage in Albuquerque as a context to imagine the future of light, color, image and text along Central Avenue. Artists and contributing curators included Pete Yahnke Railand, Lindsey Fromm, Jessamyn Lovell, Aline Hunziker and Bethany Delahunt. The catalog included an essay by Ellen Babcock, Founder, Friends of the Orphan Signs collaborative group and Assistant Professor of Sculpture at the University of New Mexico.

- Apr 18 **Call for Entries deadline** to receive submissions for the Historic Route 66-Inspired Sign Public Art Design Competition in collaboration with 516 ARTS and Friends of the Orphan Signs by the City of Albuquerque Arts Board and the Public Art Urban Enhancement Program. Design submissions were included in the exhibition *Friends of the Orphan Signs* and several designs selected by the Arts Board were purchased for the Public Art collection and/or awarded with a contract to realize the sign in the future in Albuquerque.
- May 26 **Exhibition Opening event** attended by guest curators and most artists, with live world beat music with Dan Lambert & JD Davis.
- Jun 14 **516 WORDS: Inch by Inch** poetry reading featuring three poetry legends of New Mexico. In conjunction with SAVOR Albuquerque Festival and the *Wendover Landing* exhibition, Miriam Sagan read from *The Electric Palm Tree*, and JB Bryan and John Brandi performed a Haiku Jazz tribute to Nanao Sakaki, exploring the landscape component of Haiku and highlighting Sakaki's translations of Issa.
- Jun 30 **Panel Discussion: 100 Years of Albuquerque Signs** featuring some of New Mexico's most passionate architectural and cultural historians, sign gurus and creatives speaking about 100 years of signs and the "art of roadside advertising", in Albuquerque. Led by Sherri Brueggemann, Albuquerque Public Art Urban Enhancement Program Manager, City Historian Ed Boles, Friends of the Orphan Signs Director Ellen Babcock, local small business owner, Sandy Moran of Sign Art, Russell D Brito, Manager of the Urban Design and Development Division City of Albuquerque, and local sushi chef and sign connoisseur Ben Adams discussed the role signs have played in our local personality of place, from the heyday of Route 66 to the "crap chic" quirkiness of our numerous abandoned lots and skeleton signs.
- Jul 27 **Route 66 Neon Tour** presented by the ABQ Trolley Co. and the City of Albuquerque Public Art & Urban Enhancement Program in collaboration with 516 ARTS in conjunction with the *Friends of the Orphan Signs* exhibition for a special tour of Albuquerque's most unique collections of cultural assets of the best, old and new roadside signage.

International Conference/ Symposium: ISEA2012 Albuquerque: Machine Wilderness

Re-envisioning Art, Technology and Nature

Events included Speakers, Performances, Screenings, Workshops, Demos, Interventions and Celebrations. 516 ARTS organized the conference and published a full conference program guide.

ISEA2012 (the Eighteenth International Symposium on Electronic Art) consisted of a conference, a multi-site exhibition and a season-long series of public programs around the region, all exploring the intersection of art, science and technology. Led by 516 ARTS, this project featured over 100 artists and over 400 presenters from 30 countries for the exhibition and conference, and involved over 100 partners from the region and beyond. ISEA is held every year in a different location around the world, and has a 30-year history of

significant acclaim. It was a milestone for Albuquerque to join the group of host cities that has included Istanbul, Singapore, Belfast, Munich, Helsinki and major urban centers around the globe. This project drew a wealth of leading creative minds to New Mexico, and is engaged our local community through in-depth partnerships, putting Albuquerque on the map in a whole new way. The title for the overall ISEA2012 project was Machine Wilderness. As part of a region of rapid growth alongside wide expanses of open land, New Mexico presents a microcosm of this theme. ISEA2012 Machine Wilderness presented artists' and technologists' ideas for a more humane interaction between technology and environment, in which "machines" can take many forms to support and sustain life on Earth. The project focused on creative solutions for how technology and the natural world can coexist. The term "Machine Wilderness" was originally coined by cultural geographer Ronald Horvath in the 1960s to describe the transformation of the landscape of the American Southwest caused by the automobile. For ISEA2012, the term "Machine Wilderness" was reclaimed to represent the potential for humans, animals and machines to coexist in a positive, sustainable future. ISEA2012 featured artists, presenters and organizations sought to define wilderness and our place in it in the 21st century. Subthemes in the conference included Power, Gridlocked, Creative Economies, Econotopias, Transportation, Dynamobilities, Wildlife, Trans-Species Habitats, The Cosmos, Radical Cosmologies. Focus areas included the Latin American Forum and the STEMArts Education Program.

Exhibition: ISEA2012 Albuquerque: Machine Wilderness

The main multi-site juried exhibition was on display from September 19, 2012 – January 6, 2013, based at 516 ARTS and The Albuquerque Museum of Art & History. Satellite venues were the Anderson-Abruzzo Albuquerque International Balloon Museum, the New Mexico Museum of Natural History & Science, the Alvarado Urban Farm. Shorter satellite exhibits took place at Ramosek Gallery, UNM School of Architecture & Planning and Richard Levy Gallery. Fall programs around the region included exhibits, lectures and performances. The over 100 artists were from 16 countries: Austria, Brazil, Canada, Finland, France, Germany, Italy, Korea, Mexico, The Netherlands, New Zealand, Portugal, Scotland, Spain, the U.K. and the USA. The exhibition was juried and curated through an international call for proposals, which drew close to 1,500 submissions from artists and presenters around the globe. The exhibition was accompanied by a catalog published by the acclaimed Radius Books, which was distributed internationally.

Collaboration: ISEA2012 Regional Collaboration

Coordinated by 516 ARTS, the season-long, regional collaboration involved over 100 partnering organizations including museums, arts organizations, environmental groups, government and the scientific and technological communities. 516 ARTS also published the ISEA2012 guide, which provided a full listing of ISEA2012 fall collaboration programs and events around the region, and served as central marketing of e-blast and social media announcements for the events.

ISEA2012 Downtown Block Party

516 ARTS and Creative Albuquerque presented the **Downtown Block Party** during the Intel Education Day for *ISEA2012 Albuquerque Machine Wilderness*, the Eighteenth International Symposium on Electronic Art. The entire general public was invited to this free, outdoor celebration, which featured artworks focusing on the conference sub-theme of Transportation and fun for all ages. The programs included hands-on interactive DIY demos, performances, projections, illuminated projects and kinetic sculptures. Music and dance happened throughout the event. All activities took place along Central Avenue between 4th and 6th Streets.
