Volunteer Grant Program - Through this program, in 2012 we provided grants of roughly \$1000 to Americans who applied to volunteer abroad through our network. Grant funding is used to pay for airfare and basic travel and living expenses. Applicants apply online and grant recipients are closely monitored throughout their volunteering experience. Grant recipients are expected to provide reports on how funds are used and are also expected to make posts on our website detailing their volunteer experience.

Partner Support and Foreign Volunteer Grants - Through these programs, we provide support to our diverse international partner projects - from disaster relief in Haiti to after-school programs in India to HIV clinics and prevention programs in Kenya. Partners campaign for funds via our website, and are required to report details of expenditures on our website for transparency. We also provide several Volunteer Grants to non-American citizens to enable them to serve our partners.
