THE DAY CARE AND EARLY CHILDHOOD EDUCATION PROGRAM PROVIDES CARE FOR MORE THAN 200 INFANTS AND TODDLERS AGED TWO WEEKS TO 2 1/2 YEARS AND FOR MORE THAN 750 PRESCHOOLERS IN A COUNTY-WIDE SYSTEM OF EARLY CARE AND EDUCATION. THE PROGRAM MAKES IT POSSIBLE FOR PARENTS TO WORK OR TRAIN FOR EMPLOYMENT. DAY CARE ACTIVITIES INCLUDE THE OPERATION, UNDER CONTRACT WITH THE CAMDEN CITY BOARD OF EDUCATION, OF 15 ABBOTT DISTRICT CLASSROOMS FOR THREE AND FOUR-YEAR OLD CHILDREN LIVING IN THE CITY OF CAMDEN. THE HOUSING AND SHELTER PROGRAM OPERATES A DAY, EMERGENCY, OVERNIGHT AND TRANSITIONAL HOUSING PROGRAM FOR HOMELESS SINGLE ADULTS, AND ASSISTS PARTICIPANTS IN OBTAINING EMPLOYMENT, JOB TRAINING AND PERMANENT HOUSING. THE FACILITIES OFFER HANDS-ON TRAINING PROGRAMS FOR HOUSING REHABILITATION AND MAINTENANCE SKILLS. THE PROGRAM ALSO PROVIDES HOUSING FOR RENTAL AND HOME OWNERSHIP TO INDIVIDUALS AND FAMILIES OF CAMDEN COUNTY. RESPOND EMPLOYS NEARLY 600 FULL-TIME, PART-TIME AND SEASONAL COMMUNITY-BASED JOBS IN VARIOUS RESPOND, INC. PROGRAMS. SENIOR CITIZENS ARE EMPLOYED THROUGHOUT ALL AREAS OF THE AGENCY. COLLEGE STUDENTS ARE PROVIDED SEASONAL EMPLOYMENT FOR SPECIAL YOUTH PROJECTS AND OTHER PROJECTS. RESPOND, INC. PROVIDES A PLACEMENT PROGRAM TO LOCAL STUDENTS AND SENIORS FROM THE CITY AND COUNTY OF CAMDEN, PLACING THE STUDENTS AND SENIORS WITH LOCAL BUSINESSES FOR EMPLOYMENT AND VOLUNTEER OPPORTUNITIES. THE PROGRAM ALSO PROVIDES A VOLUNTEER EXPERIENCE FOR 13 TO 15 YEAR OLDS FEATURING JOB SHADOWING, EMPLOYABILITY SKILLS TRAINING, MENTORING, AND FIELD TRIPS TO CULTURAL VENUES. NUMEROUS PROGRAMS HAVE BEEN ESTABLISHED TO PROVIDE ASSISTANCE TO RESPOND, INC. STAFF MEMBERS TO HELP FACILITATE THEIR ADVANCEMENT AND EFFECTIVENESS. THESE PROGRAMS INCLUDE CAREER PATH TRAINING, TUITION REIMBURSEMENT, PARTICIPATION IN STATE AND NATIONAL TRAINING WORKSHOPS, CHILD DEVELOPMENT ASSOCIATE CERTIFICATION AND CERTIFICATION IN OTHER EDUCATIONAL AND TRAINING COMPETENCIES.
