SEE SCHEDULE OTHE ROCHESTER GENERAL FOUNDATION CONDUCTS A BROAD RANGE OF FUNDRAISING EFFORTS TO DRIVE ANNUAL GIVING, SPECIAL EVENT SUPPORT, MAJOR GIFTS AND PLANNED GIFTS EVENT - IN 2012, THE FOUNDATION CONDUCTED MULTIPLE SPECIAL EVENTS EACH EVENT WAS DESIGNED WITH THE PURPOSE OF RAISING MONEY, THANKING MAJOR DONORS OR CULTIVATING NEW MAJOR DONORS SOMETIMES, EVENTS ACCOMPLISHED TWO OR THREE OF THESE OBJECTIVES THIS SECTION DESCRIBES SOME HIGHLIGHTS OF 2012 ROCHESTER GENERAL HOSPITAL FOUNDATION EVENTS THE MOST SIGNIFICANT EVENT OF THE YEAR, THE FOUNDERS SOCIETY GALA, WAS HELD IN NOVEMBER 2012 APPROXIMATELY, 1,400 PEOPLE ATTENDED THE EVENT AND RAISED OVER \$793,000 - A RECORD AMOUNT - BEFORE EXPENSES ADDITIONALLY, SIX PEOPLE WERE RECOGNIZED AS PHILANTHROPY AWARD HONOREES THIS WAS AN OPPORTUNITY TO THANK THEM FOR THEIR SUPPORT OF THE HEALTH SYSTEM THIS EVENT WAS ALSO AN OPPORTUNITY TO ENGAGE PROSPECTIVE MAJOR DONORS TO MAKE FUTURE GIFTS TO THE CAPITAL CAMPAIGN LUNCH AND DINNER EVENTS DESIGNED TO THANK, EDUCATE AND INSPIRE FRIENDS OF ROCHESTER GENERAL HEALTH SYSTEMS WERE PEPPERED THROUGHOUT THE YEAR AS WELL THE FOUNDERS SOCIETY LUNCHEON, THE HANSFORD LEGACY SOCIETY DINNER AND THE BOARD EMERITUS SOCIAL WERE THE MOST NOTABLE EXAMPLES OF THE FOUNDATION THANKING PAST FRIENDS AND DONORS FOR THEIR GENERAL SUPPORT WHILE ALSO ENLIGHTENING THEM ON THE FUTURE NEEDS OF THE SYSTEM AND NEW WAYS TO LEND PHILANTHROPIC SUPPORT IN THE FUTURE THE FOUNDATION ALSO HELD SEVERAL PRIVATE EVENTS THAT WERE MEANT TO CULTIVATE PROSPECTIVE DONORS TO THE CAMPAIGN PAST DONORS AND PEOPLE WHO PREVIOUSLY HAD LITTLE CONTACT WITH THE HEALTH SYSTEM WERE INVITED TO "INSIDER EVENTS", WHERE HEALTH SYSTEM LEADERS AND PROMINENT COMMUNITY SUPPORTERS SHARED NEEDS AND ASPIRATIONS FOR THE HEALTH SYSTEM AND THE REGION AT LARGE ANNUAL GIVING -THE FOUNDATION ALONG WITH NEWARK-WAYNE COMMUNITY HOSPITAL FOUNDATION, CONTINUED A DIRECT MAIL PROGRAM TO ACQUIRE MORE THAN 2,300 NEW DONORS SINCE 2012 AS PART OF THE PLANNED PROGRESSION TOWARD THE CAMPAIGN, 2012 MARKED A YEAR WHEN ACQUISITION EFFORTS WERE REDUCED AND RETENTION EFFORTS WERE EXPANDED THIS MEANS WE FOCUSED ON MAINTAINING CONTACT WITH THE DONORS WE HAVE ACQUIRED OVER THE PAST THREE YEARS, ENCOURAGING REPEAT GIFTS FROM THEM INSTEAD OF CONTINUING TO FOCUS ON FINDING NEW DONORS WHILE THIS EFFORT BENEFITS BOTH FOUNDATIONS, WHEN APPROPRIATE, DIRECT MAIL EFFORTS WERE TARGETED TO THE "NEWARK WAYNE" COMMUNITY AND THE "ROCHESTER GENERAL" COMMUNITY AS THE CAMPAIGN CONTINUES TO PROGRESS, MAJOR GIFT OFFICERS WILL TRY TO REACH OUT TO INDIVIDUALS WHO HAVE MADE MULTIPLE GIFTS AND SATISFY OTHER QUALIFYING CRITERIA TO ENCOURAGE EITHER A MAJOR GIFT OR A PLANNED GIFT
