A selection of workshops, lectures, support forums, energizers and creative activities are some of the offerings at the conference, graduate students and professionals in health, education, science and government can get a unique perspective on narcolepsy and the effect it has on individuals and families. In 2012, NN hosted the 27th annual conference in Cleveland, Ohio. 325 people attended from all over the world. The conference offered special programming for children and young adults with narcolepsy as well as sessions on research treatment and advocacy.
