Pursuant to Section 33-1157 of the Connecticut Revised Nonstock Corporation Act (the "Act"), the Connecticut non-stock corporations named herein hereby certify that:

1. The names of the parties to the merger are as follows:
 - a. AIDS Project/Hartford, Inc., a non-stock corporation organized and existing under the laws of the State of Connecticut; and
 - b. Connecticut AIDS Resource Coalition, Inc., a non-stock corporation organized and existing under the laws of the State of Connecticut.
2. The corporation that will survive the merger is Connecticut AIDS Resource Coalition, Inc. (the "Surviving Corporation"), which shall change its name to "AIDS Connecticut, Inc." as provided in paragraph 4 below.
3. The merger shall be effective as of 12:01 a.m. on January 1, 2013.
4. The certificate of incorporation of the Surviving Corporation is being amended as follows in connection with the merger:
 - a. Article 1 is deleted and replaced with the following:
 - "1. The name of the Corporation is AIDS Connecticut, Inc."
 - b. Article 3 is deleted and replaced with the following:
 - "3. The Corporation is organized and shall be operated exclusively for religious, charitable, scientific, literary or educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended (the "Code"), including: to facilitate the provision of supporting programs for persons suffering from HIV infection, using existing community resources; to promote independence, self-care and self-respect among the clients (or recipients of services); to raise funds to further said exempt purposes; and otherwise to engage in such other lawful acts and activities consistent with the foregoing for which corporations may be formed under the Nonstock Corporation Act, as the Corporation's directors may approve from time to time."
 - c. A new Article 12 is added to read is follows:
 - "12. No person who is or was a director of the Corporation shall be personally liable to the Corporation or the members of the Corporation for monetary damages for breach of duty as a Director in an amount that exceeds the

compensation, if any, received by the director for serving the Corporation during the year of the violation if such breach did not (a) involve a knowing and culpable violation of law by the director, (b) enable the director or an associate, as defined in Section 33-840 of the Connecticut General Statutes, to receive an improper personal economic gain, (c) show a lack of good faith and a conscious disregard for the duty of the director to the Corporation under circumstances in which the director was aware that his or her conduct or omission created an unjustifiable risk of serious injury to the Corporation, or (d) constitute a sustained and unexcused pattern of inattention that amounted to an abdication of the director's duty to the Corporation. Any lawful repeal or modification of this Article or the adoption of any provision inconsistent herewith by the Board of Directors or the members of the Corporation shall not, with respect to a person who is or was a director, adversely affect any limitation of liability, right or protection of such person existing at or prior to the effective date of such repeal, modification or adoption of a provision inconsistent herewith. The limitation of liability of any person who is or was a director provided for in this Article shall not be exclusive of any other limitation or elimination of liability contained in, or which may be provided to any person under, Connecticut law as in effect on the effective date of this Certificate of Incorporation and as thereafter amended."

5. The members of AIDS Project/Hartford, Inc. approved the plan of merger at a meeting held on October 16, 2012, in the manner required by Sections 33-1000 to 33-1290, inclusive, of the Act and the certificate of incorporation of the corporation; the members of Connecticut AIDS Resource Coalition, Inc. approved the plan of merger at a meeting held on October 4, 2012, in the manner required by Sections 33-1000 to 33-1290, inclusive, of the Act and the certificate of incorporation of the corporation.




