- a. Membership Services: Services to members including annual meeting, potlucks, quarterly newsletter, NOFA Notes, and quarterly newspaper, The Natural Farmer. Current membership 1,320 gardeners, farmers and consumers. (Revenues: \$2,613) (Expenses: \$98,017) (Grants: \$67,770)
- b. Ag Ed FEED (Food Education Every Day) works to promote the development of agriculture curriculum in Vermont School systems as well as the use of organic and local produce in lunch programs.
