In 2012, NJCF completed the lengthy and costly process of achieving professional accreditation, a major landmark within the land trust community. During 2012, NJCF and its partners permanently preserved more than 2,049 acres across the state, completing 28 conservation transactions. From the Highlands to the Delaware Bay watershed, NJCF preserved productive farms that keep the "garden" in the Garden State, and beautiful natural areas that provide outdoor recreation, protect wildlife habitat and safeguard public drinking water supplies. NJCF implemented a new 7.5-mile section of the Batona Trail on its Franklin Parker Preserve. NJCF organized an adopt-a-preserve volunteer program at the Wickecheoke Creek Preserve, and organized 10 workdays for corporate, student and hunter volunteers. NJCF continued to demonstrate leadership in the public policy arena. During the past year NJCF worked at the federal and state level to protect farmland and safeguard the quality of agricultural soil and water sources. NJCF also worked to ensure the long-term protection of New Jersey's forest lands by advocating for sound logging practices on state lands. NJCF supported the Keep It Green Coalition to renew preservation funding, including support for stewardship of preserved lands, state parks, forests and wildlife management areas. In 2012, the last available Garden State Preservation Trust funds were allocated for preservation projects, so without action to replenish the program, very limited funds will be available for conservation in the near future. In March 2012 NJCF again hosted the annual New Jersey Land Conservation Rally, one of the nation's largest statewide conservation training events, with over 300 attendees. During 2012, NJCF held over 30 events with its "Step Into Nature" program and attracted over 500 participants.
