EDUCATIONAL PROGRAMS - DVG OFFERED MORE THAN 55 EDUCATIONAL PROGRAMS, WORKSHOPS, TELECONFERENCES AND WEBINARS ON DIVERSE TOPICS INCLUDING ARTS, EDUCATION, COMMUNITY DEVELOPMENT, WOMEN AND GIRLS' ISSUES, FOOD SYSTEMS AND FAMILY PHILANTHROPY. ADDITIONAL PROGRAMMING TRACKS WERE OFFERED TO HELP MEMBERS LEARN BEST PRACTICES IN GRANTMAKING THROUGH SKILLS BUILDING IN PROPOSAL REVIEW, FINANCIAL BASICS, LEGAL AND ETHICAL ISSUES, EVALUATION AND GRANTS MANAGEMENT. THE ORGANIZATION ALSO HELD DIALOGUES WITH CITY AND COUNTY OFFICIALS ON TIMELY ISSUES. DVG'S MAJOR EDUCATIONAL AND NETWORKING EVENTS OF THE YEAR WERE A FALL CONFERENCE ATTENDED BY OVER 290 PHILANTHROPIC, NONPROFIT AND GOVERNMENT LEADERS, AND AN ANNUAL MEMBERS' MEETING ATTENDED BY OVER 100 GRANTMAKERS. BOTH EVENTS FEATURED PROMINENT NATIONAL AND LOCAL SPEAKERS WHO INFORMED AND INSPIRED ATTENDEES TO SHARE INFORMATION AND EMPLOY PHILANTHROPIC PRACTICES AIMED AT STRENGTHENING COMMUNITIES. COMBINED, DVG'S PROGRAMS ATTRACTED MORE THAN 1,500 PARTICIPANTS.
