



During 2012, because of current market conditions the discounted interest rate decreased by 57 basis points, which caused the present value of the defined benefit Plan's liability to increase. The impact of the increase in the present value of the defined benefit liability to an individual's deferred compensation is reflected in "Retirement and Other Deferred Compensation" in Schedule J- Part II Column (C). The increase in the present value of the defined benefit Plan's liability does not correspond to the actual benefit due to the Plan's participants which is based on the compensation structure and years of experience, for which there was no significant change during 2012.
