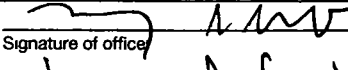

Conference to promote exchange of ideas ---> The annual conference, held in April of each year, attracts between 650 and 750 attendees. This includes students and faculty from educational and governmental institutions around the country, as well as from foreign countries. The conference provides an outlet for scholars to present their work to their peers and an opportunity for that work to be reviewed. Over 900 papers are presented during the three days of the conference.

Journal Production---> The Social Science Journal has been published by WSSA since 1963. It is currently printed and produced by Elsevier Publishing who provides the processing of the revenue that comes from the sale of the Journal. The copyright is owned by WSSA and the Journal is distributed to about 800 individuals and over 2,000 educational institutions. The Journal is published four times per years. It has a 90 percent rejection rate for submissions. About 40 to 45 scholars per years are published in the Journal. The Journal also provides book reviews.

WSSA News ---->The WSSA Newsletter is published twice a year. The Newsletter in addition to promoting the annual conference also promotes new ideas, concepts and trends in the social sciences.
