The educational opportunities provided include how to fly cast, how to tie flies and how to fly fish, in general. FFF also has a collection of fly fishing artifacts that are displayed at their national headquarter office that educates people about the history of the sport. The FFF funds grants that are used by their clubs and councils for local conservation projects throughout the United States. The FFF also provides an educational magazine (twice a year) to their members and distributes it through the many fishing fairs and expos that the organization
