OF
EMERGENCY ASSISTANCE FUND OF THE ASSOCIATION OF YMCA
PROFESSIONALS**

A Rhode Island Not-For-Profit Corporation

ARTICLE

NAME, ORGANIZATION AND PURPOSES

NAME. The name of this Organization shall be the Emergency Assistance Fund of the Association of YMCA Professionals (hereinafter, "Organization").

PURPOSES. Consistent with Section 501(c)(3) of the United States Internal Revenue Code of 1986, as amended (or any corresponding provision of any future United States Internal Revenue law), the Organization is organized and shall be operated exclusively for charitable purposes.

ARTICLE

MEMBERSHIP

The Organization shall have no members.

ARTICLE

BOARD OF DIRECTORS

GENERAL POWERS. The affairs of the Organization shall be managed by its board of directors.

NUMBER, TENURE AND QUALIFICATIONS. Three officers, seven regional representatives, two - five at-large and two AYP board members constitute the EAF board. Members must be active AYP or AYR members. Board members are limited to two consecutive three-year terms.

ELECTION. Upon the expiration of a director's three-year term, a director shall be elected by AYP members following nomination by the AYP Board Development Committee.

VACANCIES. Whenever a vacancy occurs in the office of director through resignation, death or otherwise, such vacancy may be filled by election of the remaining directors for the remainder of the unexpired term. The board shall have the authority to fill additional seats on the board which are newly created or which have remained unfilled in consultation with the AYP Board Development Committee.

Nomination, election and appointment of Officers of the Board shall be in accordance with the nominations process as set forth in Board Policy of the Association of YMCA Professionals.

Terms

The term of each Officer shall be two (2) years.

Duties

The duties of each Officer shall be set forth in Board Policy.

Removal

An Officer may be removed by a vote of at least three-fourths of the Directors present at a meeting of the Board called for that purpose.

Vacancy

If a vacancy occurs in an Officer position, except that of the Immediate Past Chair, the Board of Directors shall designate a member of AYP, to fill the vacancy for the remainder of the term.

ARTICLE

COMMITTEES

COMMITTEES. The board of directors, by resolution adopted by a majority of the directors in office, may designate one or more committees, each of which shall consist of two or more directors, which committees, to the extent provided in said resolution and not restricted by law, shall have and exercise the authority of the board of directors in the management of the Organization; but the designation of such committees and the delegation thereto of authority shall not operate to relieve the board of directors, or any individual director, of any duty imposed upon it or such person by law.

ARTICLE

OTHER PROVISIONS

Board Development Committee

The AYP Board Development Committee oversees the Organization's and the EAF's nominations process. The Board Development Committee is a standing committee of the Organization and is comprised of six (6) members with three-year rotating appointments. Each committee member serves a three-year term. The Immediate Past Chair serves on the Board Development Committee.

Nominations Process

The nominations process to be used by the Board Development Committee is set forth in Board Policy.

ARTICLE

FISCAL MATTERS

Fiscal Year

The fiscal year of the Organization shall begin on January 1 of each year and end on December 31 of the following year.

Annual Budget

Each year prior to the Annual Meeting, the Board of Directors shall adopt a budget for the next fiscal year, which may be amended as the board deems necessary.

Annual Audit

The Board of Directors shall engage a CPA firm to examine and report upon the financial condition of the Organization for each fiscal year. Such CPA firm shall be selected as set forth in Board Policy.

Indemnification and Insurance

Any appointed, elected or volunteer member ("Eligible Member") shall be indemnified by the Organization against all expenses reasonably incurred by him or her in connection with any action, suit or proceeding to which he or she may be a party defendant or with which he or she may be threatened by reason of his or her having been an Eligible Member of the Organization or by reason of having acted pursuant to a resolution of the Board of Directors, but an Eligible Member shall not be indemnified for any matter for which he or she is held liable for negligence or misconduct in the performance of his or her duties. The term "expenses" includes the amount paid in satisfaction of a judgment or in the settlement of a claim if the settlement is approved by a majority of the members of the Board of Directors of the Organization other than those involved or by a majority of the members of a committee of five or more members of the Organization who are not Eligible Member so involved appointed by the Chief Executive Officer, subject to the approval of the Board. The right of indemnification under this article shall not exclude any other right to which an Eligible Member may be entitled nor restrict the Organization's right to indemnify or reimburse an officer or director in a property case even though not specifically provided for herein.

The Board of Directors shall provide, at the expense of the Organization, adequate insurance coverage in an amount which it may specify, for all individuals entrusted with the assets of the Organization.

ARTICLE

DISSOLUTION AND PROHIBITED ACTIVITIES

Dissolution

The Organization may be dissolved in accordance with the laws of the State of Rhode Island. In the event of such dissolution, the Board of Directors, after paying or making provisions for the payment of all the liabilities of the Organization, shall dispose of all its assets exclusively to any organization or organizations which shall at the time qualify as an exempt organization or organizations under Section 501 (c) of the Internal Revenue Code of 1954 as amended (or the corresponding provision of any United States Internal Revenue Law) as determined by the Board of Directors.

Prohibited Activities

No part of the net earnings of the Organization shall inure to the benefit of or be distributable to its members, officers, directors or other private persons, except that the Organization shall be authorized and empowered to make payments in furtherance of the purposes set forth in these Bylaws. The Organization shall at no time take part in any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these bylaws, the Organization shall engage in no activities which would preclude it from qualifying under Section 501 (c)(6) of the Internal Revenue Code.

BOOKS AND RECORDS

The Organization shall keep correct and complete books and records of account and shall also keep minutes of the proceedings of its board of directors, and committees having any of the authority of the board of directors. All books and records of the Organization may be inspected by any director, officer, or committee member, or such person's agent or attorney for any proper purpose at any reasonable time.

ARTICLE

AMENDMENTS

Bylaws

The Bylaws may be amended by a majority of directors casting ballots.
