The ASR Executive Council met twice during this meeting, which is its normal expectation. The ASR annual meeting is always held immediately before or immediately after the American Sociological Association meeting, in the same city. Two of the ASR sessions during its program were joint with the American Sociological Association.

Publication of: (1) Volume 73 of the quarterly academic journal "Sociology of Religion" in cooperation with Oxford University Press, under the editorship of Scott Schieman. "Sociology of Religion" contains original research articles, book reviews, and "ASR News & Announcements," which contains informational material as appropriate to each quarter.
