Community Fund Grants \$264,637 and Donor Option Funds \$108,834--28 local programs at 14 local non-profit agencies were supported by grants through a competitive grant process of proposal and presentation to 40 volunteers from our community that made the final decisions. Donor Option Funds include donations designated by our donors to specific non-profits of their choice. Recruitment, training and support of the volunteers for the review process as well as training, accountability, and oversight of agencies receiving funds are important parts of making sure donations have the MOST impact in our community.

Community Building Activities: United Way staff and volunteers participate in, plan, lead and support various events and activities in our community in conjunction and collaboration with many other non-profits and government organizations. These activities promote healthy lifestyle choices for our citizens and address issues within our community.

Zenith Youth Leadership Academy, and 8 month facilitated leadership program for 8th graders grew in 2012 to include youth from Portales. In all 42 teens participated

Provided free health screenings and educational seminars for free to 85 adults from the community at the Health and Wellness Day Event.

2-1-1 Information Helpline for residents of Curry and Roosevelt counties. 2-1-1 staff and volunteers assisted 1533 callers in finding services. 2-1-1 staff and volunteers produced a printed directory (Summer Activity Guide) of recreational activities for children in our area to meet the needs of parents. The directory was distributed for FREE to all elementary school children in the two counties. 2-1-1 staff and volunteers helped 35 uninsured individuals apply for FREE prescriptions from pharmaceutical companies. 17 were approved, saving them \$4,751 per month (or \$57,021 annually) in prescription costs. 2-1-1 staff and volunteers distributed over 68 fans (donated by community members) to local families who did not have air-conditioning, and 3 heaters to families without heat in winter.
