Lake Charles Scottish Rite Bodies will not retaliate against an employee who discloses or threatens to disclose to a supervisor or a public body any activity, policy, or practice of Lake Charles Scottish Rite Bodies that the employee reasonably believes is in violation of a law, or a rule, or regulation mandated pursuant to law or is in violation of a clear mandate or public policy concerning health, safety, welfare, or protection of the environment.
