

This includes recruiting and background checking youth coaches, providing uniforms for both athletes and coaches as well as training equipment and materials. Striders also provide "camperships" which enable youth runners to attend running camps over The summer.

Scholarship Program Striders provide college scholarships for youth runners based on academic and athletic performance and a record of community service. Awards went to 8 student athletes, ranged from \$1,000 to \$2,500 and were paid directly to the colleges
