


Part II Line 17a The Organization meets the "over 10%" support test through various methods of public fundraising. Specifically, the two largest fundraising events in 2011 consisted of a fun walk and a "Friends Dinner." The fun walk attracted 150 attendees, of which 6 were directors or related parties. This event raised \$10,105 for the charitable purposes of the Organization. Most of the attendees for this event resided in Nebraska, with a few attendees from Iowa.

Part II Line 17a Approximately 50 donors contributed to this event but did not participate in the golf portion. The "Friends Dinner" attracted 125 attendees, of which 8 were directors or related parties. This event raised \$13,522 for the charitable purposes of the Organization. Again, most of the attendees for this event resided in Nebraska, with a few attendees from Iowa.

Part II Line 17a The funds raised by these events were used to support the University of Nebraska scholarships and to help subsidize the aphasia program at the Munroe-Meyer Institute. At least 13 scholarships were provided to needy students during 2012. Approximately 414 children were provided assistance in 3,105 sessions at the Munroe-Meyer Institute. These children came from 9 counties in Eastern Nebraska, representing approximately 10% of the counties in the state.

Part II Line 17a The governing body consists of citizens from Omaha and Ralston, NE and Council Bluffs, IA. Widespread support of this Organization is accomplished in a multi-county area of Eastern Nebraska and Western Iowa. Six of the nine board members are elected yearly. Two board members serve one year terms and four board members may be re-elected up to three years. The final three members are appointed by the Cathedral Board.
