AMENDMENTS TO BY-LAWS

ARTICLE VI

Elections

Both officers and directors shall be elected by direct vote of the membership. Voting may be conducted by mail. A member with an individual membership and two members of a family membership may each cast one vote for each office and directorship to be filled. Votes may not be cumulated. The office of any officer or director which may become vacant shall be filled by an appointment of the Executive Committee effective until the next election.

ARTICLE VII

Amendment Procedure

Amendments to these By-Laws must be presented to and approved by a 2/3 majority of the Executive Committee. Proposed amendments shall then be presented in writing to the membership at least 30 days prior to the General Meeting. Amendments will be adopted upon approval by 2/3 of the members present at the General Meeting.
