

Tenant Worker Center (TWC): This program empower workers through education and organizing to recover over \$700,000 this year in stolen wages, in partnership with Asian Law Caucus, DLSE, OLSE-including the major Pho Clement victory. In one particular restaurant case, we helped four workers recover over \$200,000 in 2 separate settlements as well as educate the employer on labor laws and reform his labor practices.

Through the Progressive Workers Alliance, we worked to pass the Wage Theft Task Force by unanimous vote of the SF Board of Supervisors and kicked off the first ever SF Wage Theft Task force with an exciting event with Dolores Huerta.

4b (Code: ) (Expenses \$ 188,484. including grants of \$ 40,940.) (Revenue \$ 96,248.)

Youth Organizing: This program strives to develop youth's leadership skills through their participation in our campaign work. This year, over 40 youth participated (33 new members). We completed our 3rd annual Youth Leadership Retreat, where 27 youth attended to learn about CPA's history and campaigns, and to build community with each other. During the summer, Youth members focused on building support for our community recommendations for the Health Care Services Master Plan for San Francisco, to these ends, members did weekly outreach in the Excelsior and collected support postcards. In total, we collected almost 500 signed postcards from residents who support making healthcare services more accessible for our communities.

Leadership Development: Our 3rd Cohort of the Eva Lowe Fellowship for Social Justice graduated this summer. This year's fellowship included new components such as an overnight orientation retreat and a SF Social Justice tour with our allies. Out of the six fellows, two have secured work with organized labor post graduation.

We also provide key leadership in the National API Organizers Exchange: Leadership of many grassroots API organizing groups from around the country met to continue discussions about building the capacity of our organizations and a National grassroots API presence. The meeting continued to build unity and trust toward more significant work together.
