The Organization primarily collects blood and blood products from voluntary donors These products are processed and distributed to various public and private hospitals The Organization collected 71,695 units of red blood cells and aphaeresis platelets from volunteer blood donors and prepared 87,090 transfusable components from these collections of voluntary donors in 2012 The Organization distributed 103,489 transfusable blood components to public and private hospitals within the State of Mississippi and the surrounding states The Organization made monetary contributions of \$17,227 to other non-profit organizations and donated 10 pieces of used computer equipment to a local public university The Organization provided 332 blood pressure and hematocrit checks free of charge to area residents Organization staff members volunteered at the City of Jackson Disability Awareness Day The Medical Director and others provided blood bank training to 3 first year Pathology Students and 16 medical technology students The Manager of Corporate Training organized and presented a 3 hour Customer Service seminar to MS Recreation & Parks Association Packets of educational material were provided to 69 elementary and high school students The MBE Crime Scene Unit was provided with 2 units of blood for training and research The Organization's staff cooked food and donated it to 25 recipients at Stewpot Community Services Staff members of the Organization also participated in a fund raising event to benefit the Multiple Sclerosis Society The Organization's President/CEO also donated his time to serve as a member of the Board of Directors for 5 other organizations
