Publication - Monthly technical (JA&WMA) and environmental management (EM) magazine is sent to approximately 4,300 members and subscribers. They include environmental issues of interest to members and the general public and other member services activities. EM had 69 feature articles, 70 feature articles published and 628 pages (543.5 of editorial). JA&WMA had 211 articles submitted and 140 published on 1484 pages. In addition, we sold 660 books/CDs/logo/full online proceedings.

Education - Workshops, webinars, courses, specialty conferences, and the annual conference and exhibition are designed to promote technology transfer and environmental awareness for members and the general public. Content from our webinars is available for those unable to attend, through on-line marketplace.

Membership Development - The membership development marketing and operations effort includes using a combination of communication tools, such as direct mail opportunities, telemarketing, monthly e-mail blast, and online tools, to achieve the proposed membership objectives. We utilize the existing association management system, as well as targeted outside prospect lists when applicable, to tailor messages and build benefit packages. Communications target them for each of the four key membership categories (individual, young professional, student, and organizational).
