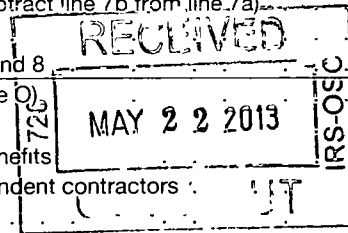

Other Expenses include travel to Ghana for general program site visits and capacity building for our partner organizations, for example fixing their vehicle so that they can monitor programs in the villages. Additionally it includes some per diem for when our Ghanaian partner came to the US in April 2012.

Other grants include small grants for health and economic programs for women. For example we completed a health center in a very rural village and we also conducted training for village women in sewing
