Our Basic Needs sponsorships provide children with the food, clothing, shelter, health care and adult care they need in order to attend and succeed in school. We focus on the most vulnerable children in need and requires that the child attend school for continued support. For 2012, our sponsors supported 757 children directly (2,000 indirectly) in 6 countries with their basic needs of food, clothing and shelter.

4b (Code:) (Expenses \$ 445,123 including grants of \$ 385,523) (Revenue \$ 416,653)

Our Primary School program focuses on improving the quality of education children receive in Primary Schools by providing desks, books, testing, after-school teaching programs and teacher support. We continue to see an increase in the number of students qualifying for secondary schools in this program. For 2012, our sponsors supported 987 star pupils along with assisting several thousand of their classmates attending primary schools in 4 countries.

Our Secondary School program provides scholarships for children to attend secondary school by providing for school fees, books, uniforms and boarding costs. In 2012, our sponsors sent 382 children to secondary school in three countries.

Except for the two organizations referenced in Part II, BrightPoint impacts other regions outside of the U.S. by giving grants to the U.S. based charity (501c(3)) of the receiving organizations. These U.S. based charities then forward the grants to their respective organizations outside the U.S. In 2011, \$793,000 was granted to assist children outside of the U.S. through their U.S. based counterparts. This amount is not reported in Part I because these funds were not given directly to organizations outside of the U.S. as specified in the instructions.

 Money is wired monthly to each of our partners outside the U.S. along with a remittance identifying the amount of the funding being sent for each program being administered by the partner. The partner will then send or take by hand the money to each of the homes/orphanages/schools that BrightPoint supports. In situations where we are paying education fees, we wire the funds directly to the school where we can. If not, our partner will hand take the funds to the school. We request receipts for the grants in these cases. Where we need to buy food, clothing, desks, etc., we will try to pay the supplier directly for the goods received and obtain a receipt in return. In this way, we limit the number of persons touching the funds. Finally, we expect each of our partners to provide us with monthly numerical reports on the use of the funds. If we are not satisfied with where the money has been spent, we will review the situation with our partners, and if necessary, discontinue our support for that particular program.

Additionally, for our key program locations, we make international on-site visits annually at a minimum to review the programs' effectiveness and evidence of appropriate program spending. These reviews are discussed with our partners.
