In and alongside those labs, MMP offered 6,500 hours of education and communications training to 275 poor and working leaders in Philadelphia and across Pennsylvania. MMP also strengthened 20 local and national community groups and organizations through narrative development, media training and education, and collaborative creation of over 50 media pieces. Finally, MMP launched and spun off a partner organizer, Put People First PA, which in the coming years will organize low-income Pennsylvanians to advocate for health care, education, jobs, and housing.
