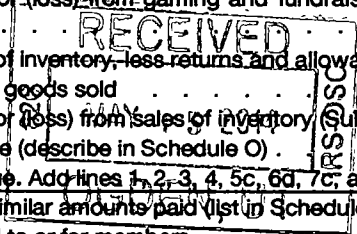



In 2012, Hands For Haiti continued supporting the Solidarity Center School in the village of Tremesse, Haiti. Funds were used as follows:

- 2) \$13,649. Funds for the construction of a new kitchen building (all building costs including site prep, construction, elec., plumbing, etc.).**
- 3) \$7,038. Funds to pay for 1 meal each day for the students at the Solidarity School.**
- 4) \$10,895. Funds for school supplies (books, paper, pencils, etc.) and satellite internet access.**
- 5) \$4,720. Funds for doctors' visits, medicine, cholera relief, and other medical costs for students and staff.**
- 6) \$5,000. Funds for purchase of additional land near the school as well as a second well to relieve the load on the primary well at the school.**

LAKAY FONDASYON, Cap Haitien and Sen Rafayel, Haiti: \$4,590

Hands for Haiti continued supporting Lakay Fondasyon in its efforts to educate indigent young people in the Cap Haitien area. Funds were used to pay for the tuition of students who were unable to attend school on their own, as well as to provide for food, housing, and medical care for these students. Funds this year were used primarily for students attending universities.

Line 16, Other Expenses.

\$1,072 was spent on Paypal and wire transfer fees for sending funds to Haiti. Donations sufficient to cover all fees were received from board members in 2012.
