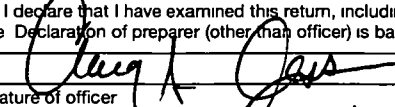

Line 33 "Yes" explanation: Foster Care Closet added additional space and and additional serviced this year. The Foster Care Closet signed a contract with the Health and Human Services Division of the State of Nebraska to provide an Intake Care Center for children at the time they are removed from their home. The case worker brings the child(children) to the Intake Care Center and stays with the child until placement is found as long as that placement is found within 23 hours. The Intake Care Center provides warm meals, new clothes, backpack for clothing articles and comfortable, safe environment for the children and the case managers while they wait for placement. Prior to opening the Intake Care Center, children had to stay with the case manager or ride around in a police car if the police were involved in the removal from the home until placement was found for the child(children). Additional space became available in the current location of the Foster Care Closet but the space needed painting, new flooring, comforting murals on the walls and lounging area for teenagers and appropriate areas for toddler and infants. Space was also developed for the case managers including WiFi access and desks where they could work while observing the children.
