The grassroots fundraising involves two or more fundraising events throughout the year, including participation in a local non-profit 5k race sponsored by the Durham Volunteer Center called the "Great Human Race" and, conducting events such as a photo contest, 5th Anniversary celebration, film showing and other cultural events to raise funds. Individual board members solicit funds from the public by hosting house parties, benefit music events and other similar events. SCSJ staff solicit funds from community-based organizations by making general information presentations about our work that are open to the public and requesting donations. In addition, the organization solicits contributions from the general public through routine newsletters and an annual year-end fundraising appeal using a traditional letter solicitation sent by mail and by email. Social media fundraising using SCSJ's website and social media accounts are conducted on an ongoing basis. SCSJ has a Charitable Solicitation license from the State of North Carolina.

The fundraising plan also includes solicitation of funds from public charities. Each year the organization identifies approximately 15-20 public charities that might contribute to the organization and sends letters of inquiry. Full proposals are submitted when permitted or requested. SCSJ has sought a few grants from governmental agencies but generally has not widely solicited funding from governmental units. In addition, SCSJ has

participated in several collaborative efforts with other non-profit organizations to solicit joint funding for specific projects from public charities.

SCSJ's main sources of support include public charities, community foundations, donor advised funds, giving circles and individual donors. Our individual supporter list includes approximately 700 individuals who have made contributions to the organization. The organization's governing body, the Board of Directors, includes attorneys, social scientists, a former city council member, and community members who represent the constituencies that the organization serves. SCSJ's services are offered to the general public on a continuing basis, consistent with the regional scope of our operations (that is, limited to the southern United States) and in line with the organization's social justice mission. SCSJ is not a membership organization.
