IN 2012, THE GEORGIA CHAMBER OF COMMERCE FOUNDATION FOCUSED MUCH OF ITS ATTENTION WITH RESULTING ACCOMPLISHMENTS ON K-12 EDUCATION REFORM AND HEALTH CARE. THE FOUNDATION HOSTED A PUBLIC EDUCATION FORUM ADVANCING INNOVATIVE CHANGES TO IMPROVE EDUCATION IN GEORGIA. IN ADDITION, PARTNERING WITH THE BILL & MELINDA GATES FOUNDATION, THE FOUNDATION LED A DETAILED EXAMINATION OF THE STATE'S EDUCATION FINANCING FORMULA AND OFFERED RECOMMENDATIONS TO THIS FORMULA TO IMPROVE STUDENT ACHIEVEMENT. DURING 2012, THE FOUNDATION ALSO RECRUITED MANY CHAMBER MEMBERS TO PARTICIPATE WITH THE STATE DEPARTMENT OF EDUCATION IN UPDATING THE CAREER PATHWAY STANDARDS AND CURRICULUM FOR THE 2014-15 ACADEMIC SCHOOL YEAR. THE FOUNDATION REMAINED ACTIVE IN PARTICIPATING IN KEY COURT CASES AFFECTING BUSINESS AND LED A COALITION OF 15 STATE CHAMBERS OFFERING AMICUS SUPPORT TO A CASE CHALLENGING THE FEDERAL AFFORDABLE CARE ACT (ACA). RELATED TO THE ACA, THE FOUNDATION ALSO HOSTED A PUBLIC HEALTH CARE FORUM EXAMINING THE POTENTIAL IMPACT OF THE LAW ON BUSINESSES IN AN EFFORT TO HELP THEM PREPARE FOR THE LAW'S IMPLEMENTATION.
